

The indicative maximum number of Equity Shares to be bought back at the maximum buyback size and the maximum buyback price is 20,00,000 Equity Shares. The actual number of Equity Shares could not exceed the indicative maximum buyback Shares (assuming full deployment of maximum buyback size) but will always be subject to maximum buyback size.
